## ZONING MEETING

Mark your calendar. On September 26, at 7:00 P.M. in St. Andrew's Church Hall, representatives from the City Planning Department will conduct an open meeting for all Highland Park residents about the proposed changes to the zoning in Highland Park.

Zoning establishes allowable uses for land and buildings. It sets the height for apartment buildings and leaves room for trees. It regulates where day care centers can go and the number of parking spaces at a store. It is simple common sense and complicated legal jargon. Zoning is what shapes the way Pittsburgh grows and helps guide the quality of life we enjoy in our neighborhoods, in our workplaces, and where we shop and play. Zoning influences every decision made about the built environment, from homes to industry, street lights to billboards.

Map Pittsburgh is an initiative of the Pittsburgh Department of City Planning to analyze, neighborhood by neighborhood, the conversion map adopted last year with the city's new zoning ordinance. The conversion map simply translates, as closely as possible, the existing zoning districts into the districts regulated by the new code. However, there are a number of ways in which the existing map does not fit either the existing neighborhoods or trends in development. Map Pittsburgh is designed to examine the fit between the newly converted districts and land use realities and trends.

The Map Pittsburgh project in Highland Park has been completed. Please attend the Tuesday, September 26th meeting to see what changes will be proposed for Highland Park.

The plan is to completely renovate the facade of this building - after the Haunted House is over. We will then sell the property to a developer - to return it to a one or two unit home. The event will run Friday and Saturday October 27 and 28, 2000.

We need volunteers to help in many areas:

- clean-up of the first floor prior to construction (debris, old furniture, broken appliances, etc.)- one weekend probably in mid-September
- design and construction of props - ongoing through October. Anyone with any ideas, experienced or not with shows, haunted house, love of Halloween, etc.
- set up- one or two weekends in October.
- event volunteers - probably four hour shifts on the event nights
  - escort (for groups of kids under 12)

- actors (in and outside the house)
  - security(in and outside the house)
  - stage crew(lights, effects, etc)
  - ticket takers
  - more
- breakdown - one or two days following the event

## Highlights of August Meeting

Called to order at 7:30 P.M.

*C.O.P. Report:* Officer Scalise reported that burglaries are up in the area and there had been an armed robbery of a pizza delivery driver. A noise problem was also reported on N. St. Clair St. She also reported that there will be a mini station opening at Vento's Pizza, near the new Home Depot. Officer Scalise again reminds Highland Park residents to be diligent in locking windows, doors, etc. and always feel free to call 911.

*Education:* Kathy Westbrook from the Fulton School PTO announced the arrival of the new Principal, Mr. Todd Van Horn. Mr. Van Horn will make a presentation at the October meeting and there will be a reception for him then. All are strongly urged to attend to discuss potential changes at Fulton.

*Farmhouse:* The insurance claim has been paid and money is being earmarked to work on the exterior as well as bring the plumbing and electrical up to code. The brick is scheduled to be stripped of paint and repointed. The purpose of the Farmhouse has not been determined. The work performed will be primarily to restore the exterior. There was an inquiry regarding a security system for the building. Steven Bruder from Councilman Ferlo's office reported that lighting, motion detectors and security are included in plans for the building.

*Zoning:* On September 26 there will be a meeting to examine recommended changes to the current code. The Pittsburgh City Zoning Board will send letters of invitation to all Highland Park residents.

It was reported that there are renovations planned for the Bunker Hill tennis courts and basketball area. A new hockey deck will also be built.

The September meeting is the annual general membership meeting focusing on election of officers. All members of the club are invited to attend and vote. Additional nominations for board members or other officers will be accepted from the floor. Refreshments will be provided by the Sacred Heart "Heart of Pittsburgh" Cookbook Committee.

Mary Lee Snuffer discussed proposed changes to the club by-laws. These changes will be printed in the newsletter and voted on in the September meeting. She thanked committee members Del Ziegler and Bob O'Connor for their work in preparing the changes.

The Highland Park website is encouraging submissions. There is also a chatroom being organized.

*HPCDC:* The CDC announced a Halloween Haunted House titled "Nightmare on Negley". The house, located at the corner of Avondale and Negley, will be open on Saturday and Sunday, October 27 and 28 from 5 to 11 P.M. The proceeds will support

the renovation of rundown properties. Please call Judy Wolfe to volunteer.

*Membership:* Kelly Meade reported current membership is 656 paying members, in addition the newsletter is distributed to 55 others on a complimentary basis. There are plans to add six nearby real estate offices to the complimentary list.

There was a cleanup at the Church at Stanton Avenue and N. Negley in May. Another one is needed; anyone who would like to organize this project is encouraged to do so.

It was reported that a resident had difficulty entering the Zoo and Aquarium through the educational complex, as was the agreement between the club and Zoo and Aquarium management. A letter will be sent to clarify the arrangement so that Highland Park residents who are members of the Zoo and Aquarium may continue to access the facility by walking instead of driving and parking.

The Club needs a Hospitality chair to arrange refreshments for the meetings and a Chair for the House Tour. Volunteers are encouraged to step forward and try one of these important jobs.

It was suggested that the club do some more social activities. A Salsa night was suggested which would include dance lessons and a variety of Salsas prepared by Highland Park residents. A site and date for this event will be announced.

Additional expressions of concern were voiced regarding Fulton School. Suggestions included making Fulton a magnet school or a school which focuses on the arts. Residents were again encouraged to attend the October meeting with ideas to discuss while the new principal is here.

Meeting adjourned.

## HIGHLAND PARK COMMUNITY CLUB BY-LAW AMENDMENTS

The following RECOMMENDED AMENDMENTS TO CURRENT BY-LAWS of the HPCC are to be voted on in the September 21, 2000 meeting. All current members of the club are eligible to vote.

### “Article III -Membership—Section 3

**CURRENT**—All candidates for Full Membership shall have submitted a written application for membership and shall have been approved for membership by a majority vote of the directors. All candidates for Associate Membership shall have been approved for membership by a majority vote of the directors or by a majority vote of the members at any meeting of the members.

**Amendment- All candidates for Full Membership shall have submitted a written application for membership and full payment of annual dues.**

### Article VIII – Officers- 3

**CURRENT**- The Executive Vice-President shall assist the President in the discharge of his duties, and in the absence of the President, he shall perform the duties of the President, and when so acting shall have and may exercise the power of the President.

**Amendment - The Executive Vice-President shall be President Elect and assumes the office of President at the designated term.** The Executive Vice-President shall assist the President in the discharge of his duties, and in the absence of the President, he shall perform the duties of the President, and when so acting shall have and may exercise the power of the President.

### ArticleVII - Officers- Section 4

**CURRENT**-The Community Development Vice President shall have the responsibility of protecting community interests and shall represent the HPCC on issues approved by the Board of Directors

**Amendment- The Community Development Vice President shall have the responsibility of protecting community interests and shall represent the HPCC on issues approved by the Board of Directors. Additionally Community Development Vice-President shall act as liaison on issues of zoning, land use, park issues and commercial development areas.**

### Article VIII-Committees-Section 3

**CURRENT** -The Finance Committee shall set up a budget for each year and shall submit the budget for approval by a majority vote(1) of the Board of Directors at the August Board of Directors meeting along with recommendation for the amount of the dues and the manner in which dues should be collected. The Finance Committee shall make recommendation on all individual expenditures not budgeted for and greater than \$50.00, at the next available Board of Directors meeting. The fiscal year shall end August 31st.

**Amendment- The Finance Committee shall set up a budget for each year and shall submit the budget for approval by a majority vote(1) of the Board of Directors at the October Board of Directors meeting along with recommendation for the amount of the dues and the manner in which dues should be collected. The Finance Committee shall make recommendation on all individual expenditures not budgeted for and greater than \$250.00, at the next available Board of Directors meeting. The fiscal year shall end August 31st.**

### Article VIII – Committees -Section 6

**CURRENT**-The Community Development Committee shall be chaired by the Community Development Vice President and shall consist of such sub committees as a quorum (8) of the Board of Directors designate

**Amendment- The Community Development Committee shall be chaired by the Community Development Vice President and shall consist of such sub committees as designated by President or Vice President of Community Development**

### Article IX – Section 5

**CURRENT** - All requests for expenditures not budgeted for in excess of \$50.00 shall be submitted in writing to the Finance Committee for their recommendations

**Amendment- Eliminate**

### Article X-Indemnification

**CURRENT**- This Corporation shall indemnify each person who is or has been a Director or Officer or who served at the request of the HPCC or another corporation, partnership joint venture, trust or other enterprise against expenses including attorney fees, judgements, fines, and amounts paid in settlement, actually or reasonably incurred by each such person engaged in the normal business of the HPCC to the fullest extent to which Directors, Officers and employees may be indemnified under the provisions of Pennsylvania Law, Sec.8367 of the Director's Liability Act.

**Amendment- This Corporation shall indemnify each person who is or has been a Director or Officer or who served at the request of the HPCC or another corporation, partnership joint venture, trust or other enterprise against expenses including attorney fees, judgements, fines, and amounts paid in settlement, actually or reasonably incurred by each such person engaged in the normal business of the HPCC to the fullest extent to which Directors, Officers and employees may be indemnified under the provisions of Pennsylvania Law, Sec.8367 of the Director's Liability Act. Copy of Insurance Policy shall be maintained by President or Treasurer."**

## Department of Public Works Announces Dedicated Park Maintenance Crews

### *A New Emphasis on Parks*

The Department of Public Works would like to announce the implementation of dedicated park maintenance crews. The reorganization of park maintenance is an effort to improve and protect the city's 2,600 acres of parkland.

Each crew is responsible for trash pickup, turf maintenance, field maintenance, weed control and other maintenance tasks in their assigned parks. Currently five of eight geographically defined park zones are in place. The Northeast Parks Zone includes: Highland Park, Homewood Park and East Hills Park. (The Northeast zone also includes Flynn Parklet, the King Estate, and ten other small parks, playgrounds, etc.) Each zone will have a designated foreman and a team of 10-19 workers.

The dedicated park crews are part of a new emphasis on parks in the City. In the past maintenance crews were responsible for both street and park maintenance. The park crews are part of a clearly defined role for city maintenance.

Each crew will concentrate their time on one specific geographic area, which will increase accountability for park maintenance. The crews will be in the same parks on a regular basis.

This program was developed under the leadership of Mayor Murphy, Councilwoman McDonald and Councilman Ferlo, and Guy Costa, Director, and Mike Gable, Assistant Director, of the Department of Public Works.
